HOW TO CALCULATE YOUR FAIR SHARE PLEDGE

The chart below is a variation of the Unitarian Universalist Association Fair Share Guide to calculate your Adjusted Monthly Income and suggested monthly pledge amount. The Stewardship and Fundraising Committee adapted it to our economic region.

To calculate your Adjusted Monthly Income:

1. Start with your monthly income, subtract any extraordinary monthly expenses such as large medical expenses, childcare, care of a parent or adult family member, or other large financial expenses. The final amount is your Adjusted Monthly Income.
2. From the Adjusted Month Income column on the left, look to the right to find the giving percentage that you would like to pledge.
