UUSO FAIR SHARE GUIDE

The chart below is a variation of the Unitarian Universalist Association Fair Share Guide. The Stewardship and Fundraising Committee has adapted it for our economic region.

To calculation your Adjusted Monthly Income:

1. Subtract any extraordinary expenses such as childcare, large monthly medical expenses, care for a parent or family member, or other large financial monthly expense.
2. From the Adjusted Monthly Income column, look to the right to find the monthly giving percentage you would like to pledge.
3. Setting up monthly online transfers from your checking account on the UUSO website makes managing your pledge easier.
4. If your financial situation changes you can make an adjustment to your pledge by contacting the Stewardship Committee Chair.
